COLLECTION OF PERSONAL INFORMATION

Personal Information is information about you that identifies you as an individual, for example, your name, address, e-mail address, or telephone number.

We may also ask you to provide additional information such as your e-mail address or your address if you want to obtain additional services, information, and receive contest prizes.

In entering the Advent Calendar competition/quiz, the participant can choose one of the answers and click on it. The user must then enter an e-mail address to participate and agree to privacy policies and terms of participation. This participation data will be gathered and includes the following information: date of participation, day of the door, e-mail address of participant and question and answer from the game.

Information might also be collected by tracking technology such as Google Analytics for counting site visits, access to pages, quizzes, and more.
